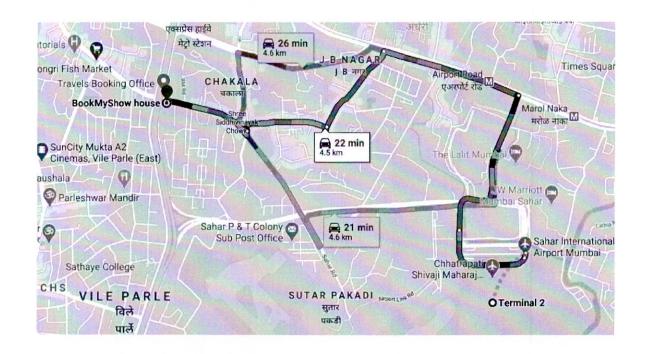
- 1. Member wishing to attend the meeting must bring the attendance slip duly signed to the meeting and hand it over the entrance.
